



2. Terms & Conditions

- 1. All Interpreting services have a minimum charge of 2 hours.
- 2. Each additional hour is billed in 30 minute increments.
- 3. Evening hours (5:00pm 8:00am) and weekends will be billed at 1.5x the hourly rate.
- 4. Time and a half (1.5x) the hourly rate will be applied for hours worked over 8 hours (billed in 30 minute increments).
- 5. RID SC:L (Specialist Certificate: Legal) or individual state equivalent will be billed at 1.5x the regular hourly rate. *Sign Language Only*
- 6. At least 2 ASL interpreters need to be scheduled for assignments lasting over 1.5 hours due to the taxing physical activity and mental focus that the interpreter needs to sustain throughout the assignment.
- 7. Two (2) or more simultaneous interpreters need to be scheduled for all assignments due to the taxing physical activity and mental focus that the interpreter needs to sustain throughout the assignment.
- 8. For consecutive interpreting, the amount of people needing interpreting will determine if 2 or more interpreters are needed.


